1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Purnea college, Purnia, established in 1948, is the oldest institution of higher education in this region. Situated on the periphery, adjoining West Bengal in the east and Nepal in the north, the institution is a commemoration of the efforts of the freedom fighters of this area. The urgency and necessity of establishing a college here compelled Sudhanshujee to move fast and it conceived first of all at Gokul Krishna Ashram in 1944 but the effect of Quit India Movement still running at a pace found the pioneers of this mission behind the premises of different prisons. The state capital being 300 kms away without road connectivity, the nearest college being 100 kms away at Bhagalpur across the river Ganga, only a few could manage to have their wards sent to far away places for higher learning.

The college has three main streams - Arts, Science and Commerce up to the Post Graduate level. The B.C.A. Hons course was sponsored by UGC in 1997 and later on B.C.A. (Semester course), B.B.A Programme were launched under self Financing scheme.

The institution is indebted to both U.G.C. and the State Government for their support. The newly built massive examination hall and a new hostel by the state Government has lessened the load to a great extent in matters of conducting examinations in a secure way and lodging facilities of students in a fair manner. The college has 118.78 Acres of campus and 41372 Sq Mts of Built Up area with a massive open ground of known as Rangbhumi Maidan comprising the Indira Gandhi Stadium built by the central government. There is enough scope of developing a sports complex in the Rangbhoomi Maidan. The college has recently been declared as a centre of excellence by the State Government but it only gives us impetus, the faculty members are aware of their responsibilities. Devoted and academic friendly teachers nourished this institution right from its inception and the process continues.

Vision

The Vision of Purnea College, Purnea is to provide quality education, while equipping students with knowledge and skills in their chosen stream, inculcate values, identify hidden talents, provide opportunities for students to realize their full potential and thus shape them into future leaders, entrepreneurs and above all good human beings. The aim of the institution is also to make this Institution as a centre of excellence in the field of higher education. A fraternity of responsible citizens committed to a national development in various fields, scientific endeavour and service to humanity a society based on mutual respect is the basic vision of this Institution. The endeavour of Purnea College, Purnea is to provide good quality education as an essential tool for gaining the best knowledge and develop modernization in society. The College strive hard to ensure that, at the completion of the elementary education cycle, every student should imbibe basic life skills, scientific knowledge, and beginning levels of numeracy and literacy.

The results of such education are visible in the form of a better and more prosperous life of the students who have studied in the College. This is mainly because of the well-structured education method which empowers students to become mindful of their liberties and obligations in a societal structure, which equip them with cognitive ability, physical growth, morals and ideas.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

Purnea College's curriculum is created and carried out in accordance with the purpose and vision of the university. At both the postgraduate and undergraduate levels, programs and classes are created with consideration for societal demands, potential for future research, NET requirements, and employability. Subject to approval by the higher academic bodies, departments are free to create and execute their courses however they see fit.

The college being Constituent unit of Purnea University follows the curriculum prescribed by the university. Keeping in view the academic calendar of the university, the institution develops and deploys action plans for effective implementation of the curriculum.

- All the heads of the department in consultation with their faculty members prepare a lesson plan with an academic calendar before the commencement of the session.
- It is ensured that teachers move from easy to difficult, familiar to unfamiliar and at a pace that is easy for learners to maintain.
- After the meetings of the different depts. The copy of the syllabus is distributed to the respective teachers. Every teacher draws his / her teaching plan broadly taking into consideration the ability of his / her students. These plans are reviewed periodically and rechecked if needed.
- The copy of the syllabus and lesson plan is also pasted by the teachers in the daily progress Register for ready reference.
- Class test is conducted at the end of each paper.
- The score of class test is considered for the eligibility for final university exams.
- IQAC committee periodically discuss the academic activities with heads of the departments and takes the account of organizing important academic events like In-house Seminars, Workshops, Debates, Group Discussions, Celebration of festivals.
- Time schedules along with teaching plans are prepared by the departments within the framework of the academic calendar issued by the university. Teaching plans are regularly reviewed and restructured, if any change comes in working days.
- The principal meets the heads of the Departments to ensure that syllabi are adequately covered.

- The subject teacher assesses the students through written class test, class debate group discussion, and Question Answer sessions.
- Students meetings are organized to encourage them to attend class discussions, seminars.
- The students are encouraged to participate in cultural and sports activities, join NSS and participate in outreach activities.
- Each teacher submits their monthly Progress Report in the Performa. The IQAC coordinator monitors the progress.

Teaching-learning and Evaluation

- With effective curriculum, we give weightage to academic meet. At the same time institution give the sufficient importance to overall development through NSS, cultural activities, games and sports. The college relies upon the globally trusted and followed teaching strategy i.e. the chalk and talk method. However, the college and teaching faculty have taken many initiatives for effective delivery of the curriculum. Heads of the departments of the college, informally meet the members of Board of Studies and HOD of other college to discuss the curriculum.
- Entrance exams are used to determine admission to all undergraduate, graduate, and research programs. Admissions are conducted as per university norms. In General Courses, such as Undergraduate and Post Graduate courses, admission are done on the basis of marks obtained in the qualifying examination. However, in case of Vocational Courses the admissions are conducted on the basis of performance in the written test and interview.
- The college conduct workshop relating to syllabus on behalf of the university. The college faculty is trained by computer department to make them familiar with the use of computer so that they are able to use the modern technological resources, internet, projector, OHPs etc, to supplement their classroom lectures. The college has created book bank for the use of teacher and students wherein all the latest books are made available to the faculty members for their references.
- The University has made an effort to use student-centered approaches to improve learning opportunities. Another unique aspect of the University's teaching and learning process is the use of technical resources like ICT and e-learning materials.
- The University's teaching faculty's academic profile satisfies both domestic and foreign standards. The majority of the faculty members posses doctoral degrees and have extensive educational backgrounds. At the state, national, and foreign levels, many of them have won honors, awards, and fellowships. In order to increase its academic diversity, the university has also been successful in luring a small number of staff members from other states.
- The results are always released by the Controller of Examinations' office in a timely manner, and the typical number of requests for revaluation is negligible. For the benefit of teachers and students, program outcomes and program-specific outcomes for the UG and PG programs, respectively, are posted on the website.

Research, Innovations and Extension

Endeavoring and pursuing Any HEI must have a robust and successful track record in both research and extension efforts and Purnea University has both. The institution has been given broad band connection under NMEICT Projects. Major Research projects sanctioned from the Ministry of Environment and Forests (Under MAB Programme), Govt. of India and Indian Council of Medical Research (ICMR), New Delhi have been completed. For advancing research, it adheres to a clearly laid out strategy. In the previous five years, a large

number of staff members have proudly accepted awards from abroad for advanced study. Additionally, over the past five years, the number of JRFs and SRFs has gradually increased, and a small number of Post-Doctoral Fellows and Research Associates are enrolled in a few University departments.

- To keep the research temper alive in the campus, the faculty members of the college are motivated to take up research projects initiated by the UGC.
- Faculty members being a member of the professional bodies like Institute for the Charted Accountant of India. Indian Science Congress etc. attend the conferences which in turn helps them in effective operation of curriculum.
- The Institution regularly organizes conferences, seminars and workshops in order to rope in researchers of eminence to visit the campus and interact with teachers and students. It also organizes dissemination lectures by the faculty to enable interaction among the faculty researchers and students.

Infrastructure and Learning Resources

Purnea College, Purnia is the oldest college of Seemanchal established in 1948. All three faculties Arts, Science & Commerce have been running since its beginning. At present nearly 6000 students are studying in all faculties. In order to create and enhance the infrastructures that facilitate effective teaching and learning, the policy is framed according to the strength of students in different faculties.

Purnea College, Purnia has excellent physical infrastructural facilities to support the teaching-learning process. Purnea College, Purnia has a total land of 118 acres and 78 decimals situated in three campuses. (Main campus of the college – 47.24 Acres, Rangbhoomi Campus – 49.18 Acres, Jankinagar Mouja – 22.36 Acres).

The College has one spacious auditorium, which is regularly used for conducting seminars of the college, state and national level. The College has 11 (eleven) well equipped laboratories, two in each physics, chemistry, botany and zoology departments as well as two in BCA vocational course, for the conduction of science practical during the session and in annual examinations. Our college has a well maintained botanical garden where the student of Botany study various plants of rare species and other aspects of botanical life which facilitates them in enriching their knowledge. The College has two well-developed computer labs in BCA.

A spacious playground in the main campus as well as large playground of stadium in Rangbhoomi campus are available for outdoor games such as cricket, football, kho-kho, hockey etc.

Proper arrangement of drinking water has also been made available in the college campus. The campus has academic faculties, departments, administrative structures, the Athletic Association, auditoriums, hostels, and residences for faculty members and non-teaching employees, among other things. The university has large classrooms to suit its requirements, and recently Smart class rooms with ICT facilities have been added to its inventory.

The institute has science laboratories with basic research facilities and library. There are many students enrolled in Ph.D. programmes.

Internet facilities have been provided to many departments to enable the faculty and students to review their research work.

Our institute library is one of the oldest libraries in this region which is utilized by researchers of this region as

well as outside researchers. The Library of the college is fully automated and it is enriched with 23307 Books and 10 Journals to its credit.

Student Support and Progression

The learning environment of the college is student centric. The learning is made student centric by adopting variations in teaching methods suited to the learning abilities of the students. In the classes where the students are of diverse learning abilities, lectures are delivered with the aim that average student will be able to assimilate the concept. The College offers a lot of support services to its teachers for making the learning student centric. Lecture method is enriched by audio-visual aids, class presentations, assignments, projects and field assignments, role plays, industrial and academic visits and orientation classes. Students are directed to the library during free hours. Conferences /Seminars/Workshops are organized on regular basis for the students. Informative guest lectures by experts from reputed institutes/organizations are organized for students to know the recent trends in the subject.

The College provides financial support to its students through freeships/ scholarships, which are given to deserving /needy / sports students. The students belonging to SC/ST, OBC and weaker sections are identified during admissions. The College provides help to these students in every possible way. Nearly 10% of students are currently availing financial assistance. Fee concessions and scholarships are awarded by State/Central Govt. and some independent societies to SC/ST, OBC, minorities, economically weaker section, physically disabled, and brilliant students.

All the first year students are required to attend computer literacy programme as per CU course curriculum. Soft skill development programmes are conducted for final year students. Moreover, the college in technical collaboration with a private computer Institute provides facility of computer courses with nominal fees to the students.

Students are helped beyond class hours. Simplified versions of books are recommended and simple handouts are distributed to them. Bilingual explanations and discussions are made. Lecture notes are provided. Special tests are conducted. Academic counseling is done at departmental level.

Several activities and compete it ions including debates, declamation contest, poetic recitation, poster making and slogan writing competition are held to nurture critical thinking and give expression and free play to their creativity. Students participate in great numbers in Science Exhibition and Quiz Compete it ions which promotes scientific temper among them. The innovative models displayed during the science exhibit ion have proved beyond doubt that some science students are still hunted by the spirit of Newton and Einstein and can prove potential innovators in future.

Governance, Leadership and Management

The institution, Purnea College, Purnia has made a special niche for itself in the past six decades. The oldest institution in the colonially defamed area, like ours, has hoisted the flag for the cause of humanity. The vision behind the establishment of the institution was very philanthropic. The founders of this institution were very philanthropic. The founders of this institution wanted the people of this border area to have an open access to

learning, irrespective of caste, colour, creed and category.

The institution, Purnea College, Purnia is governed by the Purnea University and the government of Bihar. It has taken a decentralized and participatory approach to academic functioning, where academic departments and faculties experience a significant amount of autonomy in their decision-making. Teachers, officers, and non-teaching employees make up the university's proper organizational structure, which governs how it operates. The Principal and the faculty in several sub-committees are always stepping in together for designing and proper applications of the quality policy and plans. The role of top management, Principal, including the faculty members, is to lay emphasis on quality education rather than mere mechanical amassing of quantity, through proper policy and planning which are stated bellow:

- Improvement of teaching and learning process.
- Improvement of the performance of the students.
- Establishing a healthy camaraderie between students and teachers.
- Identifying the need and requirement relating to learning process of the students from backward class.
- Up gradation of infrastructure and equipment required to modernize the education system.
- Computerization of the Office and the library for better and quicker service.
- Air conditioned computer lab for the students and teachers with internet facilities.
- Implementation of all university curricula rules and regulations.
- In the institution the other members of the committees meet and discuss the matters related to college development, infrastructural needs and student disciplines.
- Teachers who have completed their Ph. D are encouraged to complete the same.
- Apart from the above, they are further requested to participate in Seminar and other related programmes.
- If possible, teachers are encouraged to take part in international seminars also.
- A separate room has been provided to the teachers for the preparation of their lecture notes and other works relating to their studies.
- Network Resource Centre with Internet facility and INFLIBNET membership has provided to teachers for accessing different national and international academic databases.

Institutional Values and Best Practices

The College vision to "To develop the knowledge, skills and character of our students who will helps us in creating and sustaining an environment conducive to academic and professional excellence." is achieved through various activities. Environmental Consciousness and Sustainability is practiced. A Green Audit was conducted.

Gender equality is promoted through programmes for gender sensitization and self-defense for students, teaching and non-teaching staff. Gender equity, gender sensitivity promotion initiatives are organized frequently to facilitate in creating awareness among students and the public about women's rights at home, at work, and in society.

The institution conducts an Inauguration program in the beginning of the year to ensure that the newly admitted students inculcate the code of conduct. The college has defined codes of conduct for students, Teaching and supporting staff.

The institution, by providing opportunities to participate and celebrate commemorative and national days of importance to imbibe in the minds of students' awareness on contemporary issues and the spirit of Nationalism.

The institution promotes practice of national integration, communal harmony and social cohesion and fundamental duties through various programs and activities. The College focuses on the education and development of the socially and financially weaker sections of society.

1. Initiatives towards women empowerment:

The institution, through the various committees and cells like the ICC, and other committees, each of which includes a faculty member as convenor, faculty and student members. A semester-by-semester plan of action is developed for organizing various programs such as seminars/workshops and interactive sessions. The Principal, IQAC Coordinator, and Coordinators of respective committees oversee the implementation of the plan of action.

Institutional preparedness for NEP

1. Multidisciplinary/interdisciplinary:

The State of Bihar has not yet adopted the NEP and so the Purnea University. Purnea College, Purnea is eagerly looking forward to implement the NEP which can offer a multidisciplinary flexible curriculum that enables multiple entry and exits. Since the NEP aims at promoting the exclusive potential of students through a holistic multidisciplinary or interdisciplinary mode of education, the college has to be well equipped to implement NEP regulations in its curriculum. Apart from the regular courses, efforts are also being made to incorporate more certificate courses and add on courses which can be offered to the students which can nourish their career prospects. The provision for the same would be implemented according to the directives of the state government. Proper guidelines in this regard is awaited from the concerned authorities. Once implemented, the teaching learning pedagogy will adopt amalgamation of intellectual, scientific, emotional, social and cultural development among its students.

2. Academic bank of credits (ABC):

Purnea College, Purnea is awaiting the instructions and guidelines of the State Government and the University for adoption of NEP in the curriculum, since neither the State of Bihar or the Purnea University have adopted the NEP yet. On receipt of such instructions our college will register under the ABC which would permit its learners to avail the benefit of multiple entries and exit during the chosen programme, and to enable credit transfer. Undoubtedly, the initiative would be highly beneficial to the slow learners and provide flexibility to students to learn as per their ability and convenience. The proviso for the same would be implemented as per the directives of the state government and University. Accordingly, in the coming years, the college would also like to have MoUs with other institutions for collaborative ventures towards internationalization of education and joint degrees between Indian and foreign institutions. Active engagement of the Faculty will also be ensured in designing their own curricular and pedagogical approaches within the approved framework through Learning Management System. The Students will be encouraged to enroll and successfully complete the courses through online platforms which will enrich their learning experience. 3. Skill development:

It would be pertinent to mention that, the NEP has not yet adopted by the State or the University. Since, the college follows the State and University guidelines in the functioning of college, the same would only be adopted after the Govt. issues directions in this regard. Being, Purnea College, Purnea, situated in the rural outskirts of the state, students' skills will be augmented by interactions with available industry experts and other resources available in the area. The endeavour of the college has always been to offer opportunities for students to develop their skills in tandem with changing needs. Efforts are being done to incorporate Add-on courses at the earliest, which would align the curriculum with relevant industries to make them job ready by the time they graduate.

4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):

Since its inception, Purnea College, Purnea has always upheld the value of Indian Knowledge system, Indian culture and its heritage. The college commemorates the national days such as Hindi Divas, Mother tongue day, Tourism Day, Independence Day, Republic Day, Shikshak Divas, Yoga Day, etc., as an act of reverence towards Indian languages and culture. Faculty members are free to provide the classroom delivery in bilingual mode as students tend to understand better if taught in their mother tongue. The graduate students are to study the Hindi language compulsorily during the first two years of the bachelor's program. The promotion of Indian languages are also facilitated through Honours (Bachelors and Master Degree) in Bengali, Hindi, Maithili, Urdu and Sanskrit. In order to stay connected with the rich Indian culture and heritage, the students are encouraged to participate in various competitions such as essay writing, poetry, speech competition, folk song, folk dance and skit etc.

5. Focus on Outcome based education (OBE):

The Learning Outcome Curriculum Framework syllabi will be prepared as per the directions of the University, once the NEP is adopted by the State, with the final outcome expected of students of a particular course at the end of the programme. The outcomes will be delineated clearly, and the teaching plans outlined accordingly. This will enhance the quality of education being imparted to them and help align pedagogy to the desired outcomes. Presently, the Outcome of the courses being provided by the college is limited to Critical Thinking, Effective

	Communication, Effective Citizenship, Environment and Sustainability, Ethical Living, Social Interaction, Problem Solving and Analytical Skills etc., which are being taught in the classrooms by the teacher through the present curriculum.
6. Distance education/online education:	Purnea College, Purnea offers courses in the regular mode as sanctioned by the UGC. Online tools and blending learning are used to augment and enhance pedagogy. Online classes and Open Book Exams were held as per directives of the University only during the lockdown necessitated by the pandemic. Distance Education is being provided in the College by the IGNOU (Indira Gandhi National Open University), MANUU (Maulana Azad National Urdu University) and NOU (Nalanda Open University). NAU offers BA, B.Sc, BLIS, MA, M.Sc & MLIS Courses. There are 45 students studying in MANUU during the last academic year. IGNOU is offering 52 courses in Undergraduate, Master Degree and Certificate Courses. There are 3800 students studying during the last academic year in IGNOU, presently.

2.5 Evaluation Process and Reforms

2.5.1 Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

Response:

Purnea College, Purnea follows the guidelines laid down by the Purnea University in both letter and spirit. New students are informed about the class tests and attendance both in the college orientation programme as well as the department orientation programme. Furthermore, this is also highlighted in the Prospectus of the college as well as clearly stated on the college website. Faculty inform students about the assignment and test schedule well in advance. The class tests are usually conducted just after the mid semester break giving them ample time to prepare for the same. Each test is discussed in the class and the rationale for the marks given is discussed. Faculty give detailed comments and are available for further discussion. The faculty looks into cases where students fall short of attendance because of medical issues. For practical, a record of the students' progress is maintained and duly informed to the students. Students who participate in Sports, NCC/NSS activities are given additional chances for class tests if they miss it on account of participation in college linked activities. At the end of each academic year Examinations and Evaluations are conducted by the Purnea University. There is a provision for re-totaling/re-evaluation by the university. The applications collected at college level and are forwarded to the university for redressal of their grievances. In case of internal assessment of students of vocational courses, the grievances related to evaluation are addressed by the concerned department/centres.

2.6 Student Performance and Learning Outcomes

The Program Outcomes (PO) and Course Outcomes (CO) are adopted for all programs offered by the institution in accordance with "Purnea University" guidelines. The Learning Outcomes-based Curriculum Framework (LOCF) will be implemented on the NEP is adopted by the State and the University. These frameworks will be intended to suit the present day needs of the student in terms of securing their path towards higher studies or a terminal degree guiding students towards career choices. The learning outcome is elaborately discussed in the Parent-Teacher meeting. The comments and

suggestions received in the meetings are taken cognizance of. The Staff Council of the college also meets from time to time to discuss the learning outcome as well as performance of the students. On this basis remedial measures are adopted at college level. Innovative teaching methodologies are adopted to make the teaching-learning a pleasurable experience both for the teacher as well as for the student. The participation of students in teaching-learning process is ensured by motivating them to take part in classroom interactions, extra-curricular activities, educational tours and extension activities. Evaluated academic status of the students is communicated to the students and remedial classes are arranged for weak students. The college has an Internal Quality Assurance Cell (IQAC). This cell monitors the learning outcome aspects and presents its report annually. This report is discussed in the Staff Council Meeting. Appropriate measures are initiated as follow-up. The IQAC of the college has started collecting data on student learning outcomes through regular feedback from the students, alumini, parents, teachers and other group of the society. Students are also encouraged to participate in NSS, NCC activities to get encouraged in the social outreach.

The college publishes its prospectus and bulletin regularly. The website is regularly updated and it carries much major information required by the students and other stakeholders. The greenery of the college campus is maintained. From the very beginning, Purnea College, Purnia has excelled in sports activities such as football, hockey, kho-kho, cricket and other athletics as well as indoor games. The college has been participating in various intra and inters university level tournaments and won several tournaments of kho-kho, hockey, football etc, as first and second prizes in the B.N. Mandal University. In sports our college provides indoor games infrastructure to students. A spacious playground in the main campus as well as a large playground with a stadium in Rangbhoomi campus are available for outdoor games such as cricket, football, kho-kho, hockey etc. Facilities for sports like badminton, table tennis, carom etc, are provided to students in the college campus only. Our college is almost 65 years old with a heritage campus, the old administrative block was HEIZ Kothi of British collector, Despite being an old institution, the college is having a modern, well equipped and up to mark technology enabled auditorium for special seminars. The seating capacity of the hall is around 300 persons which includes the seating capacity of the gallery. Our College has two NSS units. Various socially relevant services are provided by NSS students like AIDS awareness program, pulse polio drive, adult education, survey and supervision of govt. welfare schemes for the backward and unprivileged sections of the society. Our College has an NCC unit working under the dynamic leadership of a permanent commissioned officer Dr. Patwari Yadav. The students are enrolled for B and C certificates. Strategic goals of the college are decided by the college development committee. The Principal and the staff tend to take decisions about the Institutional functioning independently. Appointment of the Faculty to the major offices such as Bursar is appointed by the university in consultation with the principal. Various committees such as IQAC, Steering, Examination, Sports, Purchase, Time table, Stock, etc are also constituted by the Principal with the consent of the staff members for smooth functioning of the Institution and achievement of the stated mission.

Annual Parent-Teacher meet strengthens the bond of the parents with the Institution. Annual Alumni meet facilitates the contribution of the alumni for the growth of the College. These feedbacks help in starting new courses or discontinuing the unfruitful ones and also strengthen the

teaching learning process.

To promote the culture of excellence an effort is made to create strategic alignment in the whole organization. This ensures appropriate design of hard systems (Policies, Procedures Process, Systems, Performances and Soft systems, Values, Commitment, Motivation, Loyalty, Communication, etc.) and progress towards the vision and mission of the Institution.

All the major stakeholders of the College including the Principal, Teaching and Non-Teaching Staff, Parents and Students work in a democratic way of governance following the tacit rules of accountability in execution of their duties and responsibilities. The primary objective of decentralisation with regard to this particular cultural event is to reorient organisational culture, thin out the official hierarchy, extend opportunities for teachers as well as students to contribute profoundly, enrich the decision-making process, and nurture greater democratic professionalism, together with proficient event management. Decentralisation of administration in Montage refers primarily to a process, in which students are given a free hand to take decisions about the judicious use of resources, financial management, execution of programmes, security arrangements, and so on. This sort of decentralisation allows the students to be more responsible, responsive, sensitive and proactive to exercise their own discretion for planning and execution in a participatory and democratic environment. The Teaching and Non-Teaching staff are privileged with Leave Benefits as per the University rules. Duty leaves are provided to attend various Orientation/Refresher/ Seminar/ workshops/Training Programs as per the Government rules. Faculty Enhancement programmes for skill up-gradation and training are organized for both teaching and non-teaching staff. Permission is readily granted to participate in Refresher Courses/ Orientation Programmes/ Short- Term Courses to the teaching staff for professional development. Computer Training Courses are provided for teachers to help them hone their e-skills and the non-teaching staff is sent to attend computer training courses organized by the University. ICT Facilities-The College is fully Wi-Fi enabled. Computer facilities are provided in the library and staff room.

6.3 Faculty Empowerment Strategies

6.3.1 The institution has effective welfare measures and Performance Appraisal System for teaching and non-teaching staff

Response:

Teacher's Self Appraisal: This provides an insight into one's own assessment of effectiveness of the teaching style and its impact on the students. It highlights how the teacher handles different situations that affect the learning progress of the students. It also makes known the involvement of the teacher in both academic and administrative activities. The performance appraisal is used for Career Advancement of the teachers who are updated about their performance at each level. If there is a scope for improvement on the part of the teacher, they are advised to upgrade themselves. The whole system is carried out in a confidential manner. Non-Teaching Appraisal: Each employee submits the Annual Performance Appraisal Report (APAR) which is Certified by the respective Reporting Officer of the employee and further certified by Reviewing Officer. Constructive feedback is given to the employee so that they can further enhance their performance level and efficiency. Teacher's Evaluation by Students: Students are given the opportunity to provide their feedback of the teachers. As per the procedures outlined by the IQAC, the feedback forms are available online on college website and the Teacher-in-Charge (TIC) ensures that the students of the department fill the feedback questionnaire. These forms are then evaluated by the Principal with the help of IQAC who analyses all the reports and meets with teachers with constructive feedback and corrective measures.

The achievements of faculty members are monitored and updated in the college records. Performance appraisal system is implemented as per the guidelines from the UGC. The appraisal report of the faculty is made by the concerned head of the department on the basis of his/her yearly achievements, discipline, quality etc. and is then submitted to the head of the institution. This besides the assessment of the teachers come through the feedback forms, which in turn indicate the teacher's quality, by the students also. All the students from each and every class and section are expected to do so for all the teachers concerned with their classes. The identities of students are not disclosed. The feedback form has a well designed set of question that helps the students to evaluate the teaching capacity based on lecture understanding and define how far the teacher has succeeded in reaching out to the students. The principal understands the student's reflections and shares it collectively and individually across the staff. The management makes an assessment of these performance appraisal forms and accordingly takes major decisions for the promotions of the teachers. They are communicated through the appropriate stakeholders and necessary steps are taken for the overall development of the college.

6.4 Financial Management and Resource Mobilization

6.4.1 Institution has strategies for mobilization and optimal utilization of resources and funds from various sources (government/ nongovernment organizations) and it conducts financial audits regularly (internal and external)

Response:

Internal Audit: Internal audit is a continuous process which ensues after each and every financial transaction, whereby the college itself carries out the initial stage of the internal audit. In the initial stage,

the officer in-charge scrutinizes and verifies the financial data. This is again scrutinized by the Administrative Officer and the Principal for clarity, authenticity, transparency and financial accuracy. Income/Expenditure is closely monitored by the Bursar and the Principal. Proper procedure for purchases is adopted. Quotations are called for and prices are compared. The audit wing of the UGC visits the college periodically and inspects all the files pertaining to the financial matters that the college has availed of and all the receipts and payments in the college. For the grants received from the UGC, utilization certificates are prepared according to the allowed expenditure under various heads. The Utilisation Grant Certificates are annually submitted to UGC. The external audit takes place annually after the completion of every financial year. The Chartered Accountant, who works as an auditor is appointed by the College. The bills and vouchers of the revenue expenditure are checked. The vouchers and proper record with the concerned Department of the capital expenditure is also checked and verified. The Utilisation Grant Certificates are audited by the external auditor. The audit objections/compliance, if any, is handled by the Accounts Department.

The Internal Quality Assurance Cell was set up on 25 Aug 2015 as a NAAC initiative well before the NAAC Cycle 1 Accreditation. Since then, the IQAC have contributed immensely towards the holistic growth of the College in the Academic and infrastructure development of the college. The entire process of assessment and accreditation gives the institution a bird's eye view of its growth as well as areas and opportunities for improvement. The IQAC works closely with departments and strategizes to improve policies, processes, and pedagogy to impart quality education to our students. IQAC has mandated many guidelines and benchmarks for every Departments and Committees of the college. The College has a rich culture of institutional functioning through participation among all stakeholders especially faculty, students and the non-teaching staff. The IQAC plays an important role in ensuring quality of the functioning of administrative and academic units of the college. Some of the initiatives of IQAC are appended below:

- 1. IQAC conducts FDPs and other seminars to bring the knowledge of the teachers at par with the latest developments in their respective disciplines.

Problems Encountered and Resources Required: The primary constraint in the implementation of the practices mentioned above is the shortage of time and space and the timely detection of students' needs. The college has to contend with a growing number of students and shortage of staff. This severely impedes the much needed one-to-one interaction between teacher and student.

7.3 Institutional Distinctiveness

7.3.1 Portray the performance of the Institution in one area distinctive to its priority and thrust within 1000 words

Purnea college, Purnia, established in 1948, is the oldest institution of higher education in this region. Situated on the periphery, adjoining West Bengal in the east and Nepal in the north, the institution is a commemoration of the efforts of the freedom fighters of this area. Late Dr. Lakshmi Narayan Sudhanshu, Ram Narayan Mandal (Both former speakers of Bihar legislative Assembly) Bhola Paswan Shastri (Ex Chief Minister of Bihar and Central Minister), noted freedom fighter and Sarvodya leader Late Baidyanath Choudhary, Late Rai Bahadur Durga, Prasanna Ghosh, Raghuwansh Prasad Singh, Upendra Narayan Choudhary, Anup Lal Mehta, Haji Ziaur Rahman, Seth Raut Mal, Kumar Bimlanand Sinha of Banaili Estate and the then District Magistrate Shiv Prasad Singh, were the inspiring force behind the establishment of this college.

The urgency and necessity of establishing a college here compelled Sudhanshujee to move fast and it conceived first of all at Gokul Krishna Ashram in 1944 but the effect of Quit India Movement still running at a pace found the pioneers of this mission behind the premises of different prisons. Just after the independence these stalwarts of the area found their dream come true. The state capital being 300 kms away without road connectivity, the nearest college being 100 kms away at Bhagalpur across the river Ganga, only a few could manage to have their wards sent to far away places for higher learning. Varanasi, Patna, Kolkata, even Bhagalpur and Muzaffarpur were out of bound for common people of this area which is predominantly connected with agriculture even today.

The college has three main streams – Arts, Science and Commerce up to the Post Graduate level. The B.C.A. Hons course was sponsored by UGC in 1997 and later on B.C.A. (Semester course), B.B.A Programme were launched under self Financing scheme. The college provides accommodation and infrastructural support to IGNOU and NOU study centres; the community college has added a new chapter in the ongoing journey of the college.

The institution, Purnea College, Purnia has made a special niche for itself in the past six decades. The

oldest institution in the colonially defamed area, like ours, has hoisted the flag for the cause of humanity. The vision behind the establishment of the institution was very philanthropic. The founders of this institution were very philanthropic. Besides they wanted the people of this border area to have an open access to learning, irrespective of caste, colour, creed and category. Vision of the college is to make this Institution a centre of excellence in the field of higher education. A fraternity of responsible citizens committed to a national development in various fields, scientific endeavour and service to humanity a society based on mutual respect is the basic vision of this Institution. Mission of the institution is "Sa Vidya Vimuktaye". With this motto this institution is engaged in promoting and propagating higher education in this backward region, strategically situated in the vicinity of international borders. The Institution solicits stakeholder perception on the overall performance and quality of education imparted in the college through feedback from students, alumni and parent meets, local elite meets apart from the opinion of visitors recorded in Visitor's Diary. These inputs are discussed in the meetings of the Principal with the Heads of the Departments and appropriate measures are initiated. This gives the scope for further improvement of the College. The college campus is situated in a natural and green environment. The institution has conducted a green audit of the campus with the help of the N.S.S. The N.S.S makes the protection of existing plants and undertakes plantations in college campus and in nearby locality. The campus is maintained green. The college has given priority for the use of technology in teaching & learning, provisions of computer, internet, Power-point presentation, SMART class room, internet. The college has adopted some best practices like regular plantation programmes in college premises and in nearby locality for protection of environment, Blood Donation Camp to serve precious human lives, empowerment of women through quality Eduaction and many others to achieve Excellency.
